DID YOU KNOW...

Advance Account Policy

Based on the University of Miami (UM) Office of Research Administration's [Advance Account Policy](#) revised on 4/03/2017, ORA allows and encourages the establishment of an Advance Account (or Accounts on Guarantee) to appropriately charge sponsored expenses for projects in anticipation of awards being funded.



Setting up an Advance Account which ensures expenses are applied to the appropriate project/grant, reduces the need for cost transfers.

When do you open an Advance Account?

When funding is imminent, an Advance Account for government contracts and grants can be requested by completing the [Advance Account Request Form](#) and submitting it to ORA, Pre Award at nra@med.miami.edu. A written justification must be included on the form detailing why the advance account is needed. In the case of government contracts, a draft contract must be submitted to be able to assess the risk of early account establishment.

The department is responsible for expenditures incurred if the award is not funded or expenditures are otherwise unallowable on the project. A cost center will be provided as a guarantee offset for those charges. Please note that the Advance Accounts can only be activated after Conflict of Interest (COI) for the project has been approved.

Caution

Advance Accounts should be carefully monitored. Ninety days after the establishment of the account, if no award/contract has been received, the account will be reviewed by post award and may be frozen.

If the award/contract is not received and/or expenses are not authorized, the PI/Department will absorb all costs incurred within the Advance Account.
