National Institutes of Health (NIH) Response March 12, 2020	*Institutions must maintain documentation of the effects and length of COVID-19 interruption to grantee operations.* Deadline Extensions <ul style="list-style-type: none">Late applications will be considered on a case-by-case basis.Advanced permission to submit late applications is not required.Late applications must include a cover letter with enough detail about the delay to make a determination as to whether circumstances justify accepting the application late.Continue to check specific solicitations for updates.	*NIH NOTIFICATION REQUIRED. Institutions must maintain documentation of the effects and length of COVID-19 interruption to grantee operations.* Closeout <ul style="list-style-type: none">Closeout reporting delays are allowed <i>by notifying the assigned grants management specialist</i>; this delay may not exceed one year.Additional project period extension beyond the first NCE requires prior approval per standard practice.
