Government Shutdown and Research

As Congress appears to have reached a deal late last week avoiding another government shutdown, the impacts are still being assessed by the individual agencies.



During the government shutdown in late December and January, many federal websites and business applications posted notices and provided shutdown <u>contingency</u> <u>plans</u> with specific information about their operations.

As with most sponsored projects, we recommend investigators and departments work closely with their central office counterparts to determine the specific impact to their federally funded projects. Also, it is important to ensure you remain attentive to notices sent out by ORA.

Effort Reporting Update

In late January 2019, ORA was able to officially close all pending Effort Certifications in the legacy Effort Reporting System (ECRT). The legacy system contained all salaries for individuals paid prior to August 31, 2017.

On February 22, 2019, the next Effort Certification period will open in the current system, which will be for the salaries paid during the period of June 1, 2018 through November 30, 2018. More details will be discussed at the ORA

Eye of the Hurricane Export Control Compliance News

U.S. Company Agrees to Pay a Civil Penalty of \$80,000 For Export Control Violation

The U.S. Department of Commerce's Bureau of Industry (BIS) and Security (BIS) has announced that Multiwire Laboratories Ltd. of Ithaca, New York, has agreed to pay a civil penalty of \$80,000 to settle charges that it committed two violations of Export Administration Regulations (EAR) § 764.2(a) (Engaging in Prohibited Conduct). Specifically, BIS charged that on two occasions, on or about February 12, 2014, and on or about August 12, 2015, respectively, Multiwire engaged in conduct prohibited by the EAR. Multiwire Laboratories exported Real-Time Back Reflection Laue Camera Detectors and Accessories, items subject to the EAR, designated EAR99 (Lowest level of control.), and valued at \$177,156, to the University of Electronic Science and Technology of China (UESTC) in Chengdu, People's Republic of China, <u>without the</u> required BIS licenses. The take way from "Multiwire's" experience – remember, "each UM associate is responsible for ensuring foreign persons, foreign entities, visitors, observers, outside service vendors, <u>have all been screened</u> to confirm that the person or entity does not appear on any of the 200+ agency lists of denied/excluded parties."

Export Control is all of our responsibilities here at the University of Miami, contact the UM Export Control Office for proper vetting and restricted party screening of foreign persons and entities.

UESTC was listed on the Entity List as "a denied party", and a BIS license was required to <u>export any item</u> subject to the Regulations to that foreign entity. Although an experienced exporter, Multiwire did not have an export control compliance program in place at any relevant time to <u>screen foreign customers against the BIS Entity List</u>, either when Multiwire first <u>unlawfully exported</u> the items to UESTC on or about February 12, 2014, or when it <u>unlawfully exported</u> the same items back to Multiwire for warranty service.
