Procurement Policy Change On Purchases Between \$10,000 and \$25,000 Charged To A Federal Award

The University of Miami has changed the procurement policy and procedures related to Federal and Federal funds flow-through awards. As of June 1, 2018, all purchase requests between \$10,000 and \$25,000 on Federal grants must be submitted with three quotes. This change is made in order to comply with the regulations in OMB 2 CFR 200 (Uniform Guidance or UG). A new approval step has been configured in the Requisition Business Process in Workday for a Federal and Federal flow-through awards for purchases greater than \$10,000. Requisitions for purchases over \$10,000 will now route to the Director of Purchasing, after all departmental and Central Offices approvals. For more information, please review the [policy](#).



Research Administration at the U

The Office of Research Administration (ORA) successfully concluded the three-day training program, Research Administration at the U. A total of 321 participants attended the sessions offered from February through May.



Successful completion of the program required passing an assessment. Of the participants required to take the assessment, 94% passed with a score of 80% or better, and the average passing score was 90.7%.

Participants (89.59%) agreed that the program improved their understanding of research administration. Those who completed the program and passed the assessment will receive a Certificate of Completion to certify they have the fundamental knowledge in Pre- and/or Post-Award.

The program will be offered again in the Fall of 2018. Dates, times and locations will be announced shortly, and registration will be available through [ULearn](#).

Coming Soon! Advanced InfoEd Proposal Development (PD) Workshop

InfoEd PD is a web-based system for submitting applications to the National Institutes of Health (NIH). InfoEd pre-populates forms, validates to insure an error-free submission, transmits application electronically, and stores proposal documentation securely.

Advanced InfoEd training will be available starting in September 2018. The interactive hands-on workshop will guide experienced InfoEd users through advanced topics in Proposal Development including:

- Multiple PI Applications
- Subawards
- Detailed Budgeting
- Human Subjects & Clinical Trials
- Validations and Troubleshooting
- Advanced Tips and Tricks



ORA will continue to offer the introductory InfoEd Proposal Development Hands-on Workshop as well. The introductory workshop leads participants through the process of creating, validating, routing, submitting, and tracking an NIH application using best practices in InfoEd. Basic NIH terms and the Standard Form 424 (SF424) will be introduced.

National Institutes of Health (NIH) – Notice of Fiscal Year 2018 Policies & Legislative Mandates

The National Institutes of Health (NIH) issued two notices in May summarizing their fiscal policies and legislative mandates in effect during Fiscal Year 2018.

[Notice of Fiscal Policies in Effect for FY 2018 \(NOT-OD-18-180\)](#)

Provides guidance about the NIH Fiscal Operations for FY 2018, and implements the Consolidated Appropriations Act, 2018 (Public Law 115-141) that provides funding for NIH for the fiscal year ending in September 2018. The notice includes updates on:

- FY2018 Funding Levels: Non-Competing Awards generally funded up to 90% of committed level, in general reductions will be fully restored.
- Ruth L Kirschstein National Research Service Awards (NRSA): NIH will increase stipends by approximately 2% on average.
- Next Generation Researchers Initiative Policy: NIH to prioritize this funding for researchers earlier in their careers.
- Salary Limits: Executive Level II salary increased to \$189,600.
